## All Veterans exposed to toxins and other hazards during military service eligible for VA health care beginning March 5

## The American Legion February 26, 2024

Today, the U.S. Department of Veterans Affairs announced that all veterans who were exposed to toxins and other hazards while serving in the military — at home or abroad — will be eligible to enroll directly in VA health care beginning March 5, 2024.

This means that all veterans who served in the Vietnam War, the Gulf War, Iraq, Afghanistan, the Global War on Terror, or any other combat zone after 9/11 will be eligible to enroll directly in VA health care without first applying for VA benefits. Additionally, veterans who never deployed but were exposed to toxins or hazards while training or on active duty in the United States will also be eligible to enroll.

As directed by President Biden, this expansion of VA health care eliminates the phased-in approach called for by the PACT Act — meaning that millions of veterans are becoming eligible for VA health care up to eight years earlier than written into law. This is a critical step forward because veterans who are enrolled in VA health care are proven to have better health outcomes than non-enrolled veterans, and VA hospitals have dramatically outperformed non-VA hospitals in overall quality ratings and patient satisfaction ratings. Additionally, VA health care is often more affordable than non-VA health care for veterans.

VA encourages all eligible veterans to visit VA.gov/PACT or call 1-800-MYVA411 to learn more and apply for VA health care beginning March 5. Since President Biden signed the PACT Act into law on August 10, 2022, more than 500,000 veterans have enrolled in VA health care.

"If you're a veteran who may have been exposed to toxins or hazards while serving our country, at home or abroad, we want you to come to us for the health care you deserve," said VA Secretary Denis McDonough. "VA is proven to be the best, most affordable health care in America for veterans – and once you're in, you have access for life. So don't wait, enroll starting March 5th."

"Beginning March 5, we're making millions of

Veterans eligible for VA health care years earlier than called for by the PACT Act," said VA Under Secretary for Health Shereef Elnahal, M.D. "With this expansion, VA can care for all veterans who served in the Vietnam War, the Gulf War, Iraq, Afghanistan, the Global War on Terror, or any other combat zone after 9/11. We can also care for veterans who never deployed but were exposed to toxins or hazards while training or on active duty here at home – by working with chemicals, pesticides, lead, asbestos, certain paints, nuclear weapons, x-rays, and more. We want to bring all of these veterans to VA for the care they've earned and deserve."

In addition to expanding access to VA care, this decision makes it quicker and easier for millions of veterans to enroll. Many veterans believe they must apply to receive VA disability compensation benefits to become eligible for VA health care, but this is not correct. With this expansion and other authorities, millions of eligible veterans can enroll directly in VA care – without any need to first apply for VA benefits.

This expansion of care covers Vietnam veterans, Gulf War veterans, Iraq War veterans, Afghanistan War veterans, veterans who deployed in support of contingency operations for the Global War on Terror

(Operation Enduring Freedom, Operation Freedom's Sentinel, Operation Iraqi Freedom, Operation New Dawn, Operation Inherent Resolve, and Resolute Support Mission), and more.

This expansion also covers many veterans who never deployed as a part of a conflict but were exposed to toxins or hazards while serving in the U.S. Specifically, under this expansion of care, any veteran who participated in a toxic exposure risk activity (TERA) at home or abroad – is eligible for VA health care. VA has determined that veterans who were exposed to one or more of the following hazards or conditions during active duty, active duty for training, or inactive duty training participated in a TERA:air pollutants (burn pits, sand, dust, particulates, oil well fires, sulfur fires); chemicals (pesticides, herbicides, depleted uranium with embedded shrapnel, contaminated water); occupational hazards (asbestos, industrial solvents, lead, paints including chemical agent resistant coating, firefighting foams); radiation (nuclear weapons handling, maintenance and detonation, radioactive material, calibration and measurement sources, X-rays, radiation from military

occupational exposure); warfare agents (nerve agents, chemical and biological weapons); and more. VA will use all available information to determine if veterans participated in a TERA, including military records and service connection.

#### Rebecca Sanin Suffolk County Legislator District 16



# Prior to your entering public service, what were your jobs in the private sector?

I have worked as a public servant my entire career in either the nonprofit sector or in government. In the nonprofit sector, my early

work focused largely on early childhood and building strong services to meet the needs of families and our youngest residents.

The brain develops most between the years of 0 and 5 and it is vital to ensure young children have access to early education, nutrition and the ingredients that support a positive trajectory for their lives. I taught Developmental Psychology as an adjunct professor at some of our local colleges.

Most recently, my work in the nonprofit sector was as the President and CEO of the Health and Welfare Council of Long Island (HWCLI), the region's health and human services umbrella agency. Here, I worked on advocacy and policy, building strong multi-sector stakeholder coalitions to solve problems and ensuring our neediest neighbors were able to be effectively served.

#### What was your first position in public service?

While I have always worked in positions of serving the public, my first position in Government was in 2012 when I started working for Suffolk County, initially overseeing constituent affairs. I coordinated efforts of addressing individual and community concerns for individuals and families all across the County.

A few months after starting in that position, Super Storm Sandy hit our region and I played a key role in helping communities navigate, working with disaster recovery centers and addressing the short-term crisis and long-term planning needs in Suffolk County.

I was eventually promoted to Assistant Deputy County Executive where I worked on making government more effective and efficient and worked with nonprofits to better serve vulnerable families. I am happy to be back at the County and to use the vast experience I have inside and outside of government to ensure Suffolk

County residents can live their best lives.

## How do you see yourself helping veterans in your role as a Suffolk County Legislator?

Veterans are a priority to me as the granddaughter, niece and daughter of veterans. Suffolk County is home to the greatest population of Veterans in our State and we must do more to protect and serve those who protected and served us.

On an individual level, my office is well acquainted with the services at the Northport VA as well as the supportive nonprofits in Suffolk County that work with and serve veterans. This is important because constituents reach out regularly and serving them with distinction and honor is a vital priority. Notes from the March 11, 2024 VSO Meeting:

- \* The parking project has been slightly delayed due to weather. Water issues are a result of construction but are remedied as soon as possible. Elevator in Building 11 (interior) is being repaired, The external elevator is another project.
- \*VAMC Northport has been inspected by different organizations (Mental Health and TLC). Both are expected to receive excellent marks.
- \*COVID update only one admission, others being followed as outpatients.
- \*Much discussion on PACT Act as it enters new phase.

The VBA, has given out 1.85 Billion dollars in benefits from the program. 4.1 million have had exposure survey

- \*There is no need to be service connected for toxic treatments. Toxic Exposure Risk Activity (TERA) is not limited to primary care, screening can be in specialty care.
- \*VA is trying to be proactive rather than reactive on toxic exposure.

#### **Thread of Resilience Project**

According to the Department of Defense, in the year 2022 there were 8,492 reports of sexual assault in the military. The Air Force saw an increase of 13%, the Marine Corps saw an increase of 3% and the Navy saw an increase of 9%. The Army saw a decline.

The Thread of Resilience Project at the Northport VA is a program where veterans are interviewed about their experiences of military sexual trauma. I took part in the program and was interviewed by a fellow female veteran over the course of an hour at the Northport VA. A photographer took pictures of my left hand which was covered by a red thread to symbolize resilience. It was an incredible experience and a cathartic one as well as I

was able to verbalize the trauma I encountered while serving in the Marine Corps.

During the month of April an exhibit will be shown in the Lobby of Building 200 at the Northport VA. All veterans who come to the VA for appointments during the month of April can view for themselves the photographs and statements of the veterans who participated in this noteworthy program. I thank the Social Work Department at the VA and the veterans who worked in tandem with the social workers to make this exhibit possible.

#### **Your DD214**

#### What is a DD214?

The Defense Department issues to each veteran a DD-214, identifying the veteran's condition of discharge - honorable, general, other than honorable, dishonorable or bad conduct.

#### Why is a DD214 important?

The Report of Separation contains information normally needed to verify military service for benefits, retirement, employment, and membership in veterans' organizations. Information shown on the Report of Separation may include the service member's:

- Date and place of entry into active duty
- Home address at time of entry
- Date and place of release from active duty
- Home address after separation
- Last duty assignment and rank
- Military job specialty
- Military education
- Decorations, medals, badges, citations, and campaign awards
- Total creditable service
- Foreign service credited
- Separation information (type of separation, character of service, authority and reason for separation, separation and reenlistment eligibility codes)

To request military service records held by the NPRC, veterans and the next-of-kin of **deceased** veterans can use their web interface at **vetrecs.archives.gov** 

Or they and others can use the **Standard Form (SF) 180, Request Pertaining to Military Records** (link is on the vetrecs.archives.gov page. Although not mandatory, the SF 180 is the recommended method to send a request for military service information. This form captures all the necessary information to locate a record. Provide as much information on the form as possible and send copies of any service documents that you may have. Requests may also be submitted as a letter. Your letter should parallel the basic information requested in the SF 180. Please see that form for details on the information that you should include within your letter.



All members are encouraged to provide a copy of your DD214 to your Post1244 Adjutant.

Your Adjutant will also have copies of the SF 180 form for you to use. You may white out your social security number.

Your post can then provide a copy to you or your next of kin whenever needed.

Finally, the day came to report. While walking to the plane, my thought was "What the hell am I doing?" But I got aboard and we were on our way.


After a long, long flight we landed at Manas Air Base - a transit center in Kyrgyzstan. There we would be issued new body armor and Kevlar helmets and then


