## Armed Forces Flags Installed at Greenlawn Memorial Park



Representatives of National Grid, the Greenlawn Fire Department, American Legion Post 1244 and town officials gathered at the entrance to Greenlawn Memorial Park to dedicate six new flagpoles displaying the flags of our United States' six branches of service. The flagpoles were donated by National Grid as part of their New York Day of Service 2021. The flags will fly on appropriate days during the year.

After remarks from representatives of the Greenlawn Fire Department, National Grid officials and Commander Donna Boyle of Post 1244, as well as Huntington Town Supervisor Chad Lupinacci and Councilman Mark Cuthbertson, the flags were raised to full height by two members of each of the three organizations.

Many improvements have been made to the Greenlawn Memorial Park in recent years since 2017 when Past Post Commander Dennis Madden and former Fire Commissioner Bill Irving teamed up to restore and improve the park's monument. The improvements have continued under the dedicated watch of Bill Irving and other volunteers. Greenlawn Memorial Park is a real gem that we can all be proud of.

Due to the Covid pandemic, Boys State and Girls State programs were cancelled in 2020. Well, we are back! Almost, anyway. Not knowing whether we would have a program this year, we went ahead with our interviewing process. We selected some 24 candidates from five high schools in our area. We explained to the candidates that we may not have the program, or the program may be modified. Undeterred, the candidates continued with the applications process.

Finally, a decision was made to have a virtual program as virus variants and a slowdown in vaccinations increased Covid cases. This was a first for Boys/Girls State managers. Technology as well as programs would be a challenge. A virtual program would also limit the opportunities for candidates to interact with one another which is one of the most popular aspects of Boys/Girls State.

We had no need to worry as it turned out. Twenty-two of our Boys/Girls State candidates came to our August and September monthly meetings to tell us of their experiences attending the program in July. Consistent with years past, their comments were positive and enthusiastic, even allowing for some new technical issues which they found more a challenge than a problem. We thought that this spoke well for those who ran the program. They were able to adapt to the situation handed to them.

It was gratifying to have state, county, and Town of Huntington legislators, supervisors and administrators personally present certificates, letters, and proclamations of achievement, recognition, and congratulations to our Boys/Girls State candidates at our August and September meetings. Among them were: New York Assemblyman Steve Stern, Suffolk County Legislator Tom Donnelly, Suffolk County Legislator William Spencer, Huntington Town Supervisor Chad Lupinacci, Huntington Town Councilman Mark Cuthbertson, Huntington Town Councilwoman Joan Cergol, Huntington Town Councilman Ed Smyth, Huntington Town Clerk Andrew Raia, Huntington Town Receiver of Taxes Jillian Guthman, Huntington High School Principal Brendan Cusack, former Superintendent South Huntington School District Dave Bennardo, Walt Whitman High School Principal Ken Costa, Walt Whitman High School Assistant Principal Corey Blair, Harborfields High School Principal Tim Russo, and Harborfields School District Superintendent Rory Manning.

New York Supreme Court Justice Jerry Asher, a member the American Legion, was also among the speakers congratulating our 2021 Boys/Girls State candidates.

The Greenlawn Post 1244 Boys/Girls State Committee will soon begin interviewing candidates for the Class of 2022. We look forward, with hope, to a more normal program.

## Post Service Officer - You Earned It!



Veteran benefits aren't just nice perks - they are something you earned through your service in the military. Good news - many VA benefits will be expanding in 2021 thanks to **Isakson and Roe Veterans Health Care and Benefits Improvement Act of 2020** which was enacted on January 5, 2021. Below are a few new items that you might not be aware of:

### **Whole Life Insurance**

Beginning in 2023, the VA will be getting into the life insurance business.

The new law requires the VA to offer all ***disabled veterans under age 81*** a whole-life insurance policy. Whole life insurance is a life insurance policy which is guaranteed to remain in force for the insured's entire lifetime, provided required premiums are paid, or to the maturity date. This new program will be similar to Veterans Group Life Insurance (VGLI); however, veterans must sign up for VGLI within 16 months after leaving the service. The new insurance program will have no such time limit.

Policies will be limited to a \$40,000 payout for most veterans when the program begins

### **Memorial Benefits**

Within two years of the bill becoming law, the VA will begin paying the costs to transport a deceased veteran's remains to state and tribal veterans' cemeteries. Currently, the VA will pay only to transport a deceased veteran's remains to a national veterans' cemetery.

In two years, the VA will begin furnishing urns for storing the cremated remains of deceased veterans. Families will have the option of receiving a free headstone or burial urn, but not both. Currently, most veterans are eligible to receive a free headstone upon their death, but not an urn.

Also, veterans who receive the free VA-issued headstone and are buried in either a state or private cemetery will be able to have their spouse's name engraved on the headstone at no cost. Currently, the family must pay to have the spouse's name engraved on a VA-issued headstone. ***This will be effective for deaths going back to Oct. 1, 2019.***

Yet another way of saying – ***Thank you for your service!***

I remember trying to capture the peace, beauty and promise of the moments of wonder.

The morning saw a new day, full of adventure. My wife and I had cancelled our plans to spend the week in New York City, celebrating my birthday. Monday we were to have breakfast near the Empire State Building, Tuesday near the World Trade Center then each landmark for the rest of the week. My granddaughter who had a birthday in a few weeks ahead, wanted a special Teddy Bear. We cancelled our plans and decided to spoil her with a custom made bear.

We headed out after breakfast to the Vermont Teddy Bear Factory. The sun kissed our cheeks. A gentle breeze danced over head. I was very grateful for the opportunity to bring joy to my granddaughter for her upcoming birthday.....

### The Days After

Ever so suddenly, our Country changed. The events of 9/11 impacted so many people, so many lives, so many policies and futures.

Our Country and fellow citizens unified as one to strive to rescue or recover those lost. Over 100 of the 343 firefighters still remain lost today.

The horrific smells, ash as well as products of destruction in the air will inflict medical challenges and death on so many more in the years since and to come. I will lose many fellow firefighters to cancer. The search for the murderous mastermind and his henchmen will cover a good portion of our Earth. Justice will be swift. The "War on Terror" will also take its toll on our Armed Forces.

Our outlook and policies will be evolved to what we hope is more secure. We, I pray, will be more aware and vigilant. The clues leading up to this event were there, were missed.

I have stood amongst the remains as I knelt to mourn my Brothers. My tears flow freely, I am not ashamed, for those lost, are a part of who I am. Their legacy is why I serve to the best of my ability. The smoke, soot and ash covered faces are no longer there to warn us but seared into memories to remind us. The site has been cleared, not to hide the magnitude of the murder but to encourage us to rebuild and progress ahead.

We bonded very early with Marie. She became part of our family. We shared many meals and laughter often

throughout the course of our days together.

Marie left us early in September to pursue her dream of becoming a LPN. How ironic, that so many of our fellow Americans criticize our country, while an immigrant to the U.S. takes pride in her work and has ambitions to better herself and her family,

We feel truly fortunate to have become friends with Marie and to have had her in our home this past summer. As is often said, people come into our lives for a reason. Marie appeared at the perfect time for us.

As a firefighter here in New York, I have stood to mourn with my brothers and sisters the many who are eternally heroes in the eyes of mankind and God. It is their courage and sacrifice that will give us, who survive the courage, strength, and determination to carry on. May eternal God keep them, bless them, and protect their valiant souls. For now, and forever.
